Unit description

This unit introduces you to the common musculoskeletal conditions relevant to chiropractors in primary care settings. You will be instructed on how to interpret clinical history, examination and investigation findings, and how to plan and execute an orthopaedic physical examination for common musculoskeletal conditions. The knowledge and skills acquired during this unit are fundamental for developing your diagnostic proficiency in chiropractic practice.
