Unit description

Teaching Mathematics, Science and Technology in the Primary School 2 is the second of a three unit sequence. It builds on knowledge acquired in EDST8203 in relation to the NSW Mathematics K-6 and Science and Technology K-6 syllabi. Teacher Education Students are supported to develop a research-based approach that supports primary students' conceptual and developmental stages of learning in Mathematics, and Science and Technology.

Designing and carrying out simple science investigations for primary science

Assessment Type 1: Practice-based task Indicative Time on Task 2: 35 hours

One of these will be selected, and a summary generated detailing how it could be incorporated into a larger science unit of learning.

Case Study Mathematics Teaching and Learning

Assessment Type 1: Case study/analysis

Indicative Time on Task 2: 35 hours

Due: 23:55 13/10/2024

Weighting: 60%

Interview one primary school student .Interpret the data from the interview to write a brief summary (report) of what the student understands about mathematical concepts and skills, drawing links between the knowledge they demonstrate and the strategies they use.

Design a lesson for the student that you believe will develop their understanding and those of other students in their class. Justify your planning decisions by using the interview data and references to mathematics education literature.
