Unit description

Responding to the challenges of the twenty-first century requires learners to be engaged, innovative and enterprising with the confidence and skills to use critical and creative thinking. As educators we need to know how to nurture thinking that is productive, purposeful and intentional and be able to design learning experiences that encourage learners to become more confident and autonomous problem-solvers and thinkers. This unit will address the critical knowledge of enrichment thinking including theories of cognition and cognitive development and explore research-informed strategies for the explicit teaching and embedding of critical and creative thinking in a range of learning areas and educational contexts.

5Rs Framework

5Rs Framework

The 5Rs Framework, developed by the School of Education at Macquarie University, is embedded throughout your teacher education course.

Your use of the 5Rs Framework will help you develop the capabilities that will make your teaching career sustainable and fulfilling.

In this unit, you will learn using the 5Rs framework in the following important ways:

- Resilient: Assessment Task feedback aims to focus on the development of academic skills including critical thinking and using feedback to improve performance.
- Reflexive: Workshop activities provide opportunities for students to reflect on their own strengths and skills and to show how they can adapt to meet the learning needs of their students. Assessment Task 2 requires a pedagogical reflection.
- Research Engaged: Assessment Task 1 requires a literature review. The literature review provides the scholarly base for completing Assessment Task 2.
