Unit description In this unit you will develop practical skills to design a Public Health research project. You will build on your previous knowledge of epidemiology and biostatistics particularly in study design; and extend into literature review, selection of research methods including when to use quantitative and qualitative methods and synergies between them, research governance and ethics applications, developing a research proposal, and disseminating research. You will be able to learn these skills and apply them in the context of a research topic in an area of your interest.
