## **General Assessment Information**

### **Late Assessment Submission Penalty**

# **Creative Project Proposal**

Assessment Type 1: Plan

# **Ensemble Project**

Assessment Type 1: Creative work Indicative Time on Task 2: 40 hours

Due: Thurs 10/10/2024 (Wk10) during class time

Weighting: 40%

Working in groups, students will plan and realise a musical piece in which each student makes a contribution. Students will critically analyse the creative process, their individual contribution and project realisation in written documentation. Refer to iLearn for further details.

# **Creative Project**

Assessment Type 1: Project

Indicative Time on Task 2: 50 hours

Due: Presented live in Wk13 (times TBA) Written: 23:55 27/10/24

Weighting: 50%

This creative project entails a performance or recording that is developed from the original Creative Project Proposal. Students are required to submit written documentation on their creative processes, project realisation and outcomes (with a credit list as appropriate). Refer to iLearn for further information.
