#### Unit description

This unit gives students the opportunity to engage in the composition of a self-directed research project, under the supervision of a subject area expert. This unit will necessitate students to thoroughly engage with the existing research on their topic, using it as a stepping-stone in developing their own research skills. Students will be mentored and trained on how to devise a research questions, translate this question into a set of research tasks, synthesise an appropriate methodological framework, conduct a literature review, collect data, and write up the result of their research as a coherent long research essay. This research relies on utilizing academic secondary sources and does not require original empirical work. Students intending to take this unit must contact any of the departmental administrators in the Department of Security Studies and Criminology to discuss eligibility criteria and supervision arrangements at least four weeks before the start of semester.

# Research Essay

Assessment Type 1: Essay

Weighting: 60%

The final submission must be a complete, integrated, and synthesized piece of work. It should take account of feedback that has been provided on the earlier drafts. Submissions should be organised in a logical and structured way, including (where appropriate) sections and subsections with headings.

# Research Essay Plan

Assessment Type 1: Plan

Indicative Time on Task 2: 5 hours

Due: Week 7 (8 September) 23.55

Weighting: 15%

The research essay plan should be a maximum 2 page dot-point outline of the research project.

# Research Proposal

Assessment Type 1: Essay

Indicative Time on Task 2: 10 hours

Due: Week 4 (18 August) 23.55

Weighting: 25%

The purpose of the research proposal is to provide an outline of the proposed research project and to demonstrate that the research question(s) can be examined in-depth within the allocated time period and word limit. The proposal should be between 750 -1,000 words in length.

#### SUBMITTING ASSESSMENT TASKS

- All text-based assessment tasks are to be submitted, marked and returned electronically.
   This will only happen through the unit iLearn site.
- Assessment tasks must be submitted as a MS word document by the due date.
- Most assessment tasks will be subject to a 'Turnitln' review as an automatic part of the submission process.
- The granting of extensions is subject to the university's Special Consideration Policy.

#### LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, a 5% penalty (of the total possible mark) will be applied each day a written assessment is not submitted, up until the

7th day (including weekends). After the 7th day, a mark of '0' (zero) will be awarded even if the assessment is submitted. Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical issue.

This late penalty will apply to non-timed sensitive assessment (incl essays, reports, posters, portfolios, journals, recordings etc). Late submission of time sensitive tasks (such as tests/ exams, performance assessments/presentations, scheduled practical assessments/labs etc) will only be addressed by the unit convenor in a Special consideration application. Special Consideration outcome may result in a new question or topic.

#### WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words deviates from the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words deviation from the word limit. If a paper is 300 words over, for instance, it will lose 3 x 5% = 15% of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.
