Unit description

This unit introduces students to scenario planning and simulation (serious game) techniques as critical thinking tools in the context of security policy analysis and planning. In the first modules, students are introduced to the broad logic and use of scenarios and simulations, as well as to their strengths and weaknesses. The second part of the unit is structured around one main contemporary security and criminology-related question that is examined in detail using scenario planning techniques and the conduct of a serious game. Students enrolled in this will take the role of the cyber security analyst.

### Scenario planning exercise

### Policy Brief

Assessment Type <sup>1</sup>: Professional writing

Indicative Time on Task <sup>2</sup>: 41 hours

Due: **30 September**

Weighting: **40%**

Students will write a policy brief focusing on the cyber security dimension of a crisis scenario.

On successful completion you will be able to:

- Demonstrate understanding of decision-making, bargaining situations and group dynamics in a political-strategic context.

- Use tools and software commonly used to attack/protect networks in complex and evolving real-world situations.

## Simulation

Assessment Type <sup>1</sup>: Presentation

Indicative Time on Task <sup>2</sup>: 25 hours

Due: **Week 13-14**

Weighting: **45%**

In the course of the main simulation, each student team will be presented with an evolving security scenario. At the end of each turn,

- each student will submit a short video presentation that assesses the cyber security dimension of the security situation and provides policy recommendations.
- each team will submit a presentation that assesses the security situation and provides policy recommendations.

On successful completion you will be able to:

- Apply scenario-planning techniques to major contemporary security- and criminology-related issues.
- Communicate disciplinary knowledge to professional audiences.
- Demonstrate understanding of decision-making, bargaining situations and group dynamics in a political-strategic context.
- Use tools and software commonly used to attack/protect networks in complex and evolving real-world situations.

## SUBMITTING ASSESSMENT TASKS

- All text-based assessment tasks are to be submitted, marked and returned electronically. This will only happen through the unit iLearn site.
- Assessment tasks must be submitted as a MS word document by the due date.
- Most assessment tasks will be subject to a 'Turnitin' review as an automatic part of the submission process.

## LATE SUBMISSION OF ASSESSMENT TASKS

Unless a Special Consideration request has been submitted and approved, a 5% penalty (of the total possible mark) will be applied each day a written assessment is not submitted, up until the 7th day (including weekends). After the 7th day, a mark of, 0 (zero) will be awarded even if the assessment is submitted. Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical issue.

This late penalty will apply to non-timed sensitive assessment (incl essays, reports, posters, portfolios, journals, recordings etc). Late submission of time sensitive tasks (such as tests/exams, performance assessments/presentations, scheduled practical assessments/labs etc) will only be addressed by the unit convenor in a Special consideration application. Special Consideration outcome may result in a new question or topic

## WORD LIMITS FOR ASSESSMENT TASKS

- Stated word limits include footnotes and footnoted references, but not bibliography, or title page.
- Word limits can generally deviate by 10% either over or under the stated figure.
- If the number of words deviates from the limit by more than 10%, then penalties will apply. These penalties are 5% of the awarded mark for every 100 words deviation from the word limit. If a paper is 300 words over, for instance, it will lose  $3 \times 5\% = 15\%$  of the total mark awarded for the assignment. This percentage is taken off the total mark, i.e. if a paper was graded at a credit (65%) and was 300 words over, it would be reduced by 15 marks to a pass (50%).
- The application of this penalty is at the discretion of the course convener.

## REASSESSMENT OF ASSIGNMENTS DURING THE SEMESTER
