#### Unit description

This unit examines the role of play in children's lives, their learning, development, and wellbeing from historical and contemporary perspectives. Students develop theoretical understandings of the characteristics of children's play. Students will explore how environments, resources, and teaching techniques can be structured to facilitate children's active and meaningful engagement in the learning process. Students will analyse the developmental and educational potential of children's play and play experiences across a range of diverse contexts.
