Unit description Contemporary music production and composition is increasingly reliant on computer technology. In this unit, students are introduced to principles of composition and production using specialized software programs and virtual instruments. Students develop technical skills as well as compositional literacy. Creativity is encouraged, as students produce original musical works within the dedicated music computer laboratory. While music production software is used in this unit, no prior computer production or musical ability is necessary.

## General Assessment Information
