Examine economic variables and how rises and falls in these variables affect individuals, businesses, and industries. Acquire skills to apply experimentation in organisations.

## Applied managerial economics task

Weighting: **50%**

This 2,000 word written submission will bring together the concepts and ideas that the unit analyses.
