#### Late Submissions

### Public health journal club

Assessment Type 1: Case study/analysis Indicative Time on Task 2: 20 hours

Due: Tuesdays Week 3 to 9

Weighting: 30%

Lead one journal club style presentation as discussant and act as reviewer for other students' selected papers. As discussant, you will summarise and evaluate a published public health manuscript, including the relevance of the research and findings to public health and implications for public health practice. As reviewer, you will engage in discussions and questions of selected papers as led by the discussant.
