Assessment Type ¹: Design Task

Create a mind map of the potential mathematics concepts embedded in a provided realistic context. Explication of this mind map to consider the possible alternate conceptions for these concepts. Design and record a resource that describes and justifies the mind map concepts and articulates possible alternate conceptions for one of these. Critical analysis of the important mathematical knowledge, skills, language and working mathematically processes is then outlined in relation to the chosen content.
