Unit description

This unit introduces best practice approaches to handling complex organisational problems with tools and methods that enable the transformation of data into insights. It also focuses on developing theoretical and practical analytical skills, such as research, critical thinking, scanning, pattern recognition and creative problem-solving. Format: Individual presentation including visualisation of data and executive summary.

You will be creating a presentation of your findings and analysis as well as providing an executive summary based on your findings. You will submit your completed task via the Assignment submission link in your online unit.
