Unit description

This unit introduces the skills, techniques and knowledge required by professional interpreters to competently work in specific institutional settings, primarily medical interpreting and legal interpreting. Through a mix of theory and applied practice, you will learn about the broader contexts of these domains and then prepare for a simulation of a typical interpreting scenario for each of these settings. You will build skills in terminology and glossary development, discourse management, message transfer, and reflective self-analysis.

#### Portfolio - self assessment

Assessment Type 1: Reflective Writing Indicative Time on Task 2: 40 hours

Due: end of each module - mid semester break and exam period

Weighting: 40%

After each interpreting performance you will be given a copy of your interpretation as a video clip. You are required to write a report analysing your performance.
