Unit description

This unit focuses on so-called abnormal behaviour. Following a general introduction to the nature and study of abnormality, as well as diagnosis, each of the main forms of psychopathology are discussed. Research and theory are reviewed, and science-based interventions are noted. An intermediate level of research methodology and statistical knowledge is a pre-requisite for this unit, as this knowledge is required to understand the scientific basis of psychopathology and its theories.
