Unit description

This unit covers theoretical models and approaches regarding the evidence-based assessment of neurological disorders, autism spectrum disorder, learning disorders, intellectual disabilities (children and adults). Assessment techniques will include clinical interviews, self-report measures, and behavioural observations where appropriate. Material will also cover considerations for applying evidence based psychotherapies using e-health applications, including telemedicine and taking into account ethical considerations and practices when working with e-health applications and clients across the lifespan.
