Unit description

This unit is designed as an introduction to common neuropsychological disorders including disorders of memory, executive functions, perception, praxis and language. Models of normal and abnormal function and case examples of dysfunction are presented. This unit is designed to provide insight into how neuropsychological disorders typically manifest. It provides you with an understanding of how functions such as memory, executive abilities, perception, praxis and language are typically disrupted as a result of neurological dysfunction. The unit relates to material taught in psychological assessment, professional practice, neuroanatomy and neuropsychological practice.
