You will present the outcomes as a research report and as a presentation.

### Research Project Report

Assessment Type <sup>1</sup>: Report

Indicative Time on Task <sup>2</sup>: 80 hours

Due: **2025-10-13**

Weighting: **50%**

## Research Plan and Critical Analysis

## Research Project Presentation

Weighting: **25%**

This assessment involves an oral presentation of the outcomes of a research project, including a review of the literature, a description of the methods and outcomes, and implications for practice.
