Unit description

This unit will provide you with the knowledge and skills to assess a client for their suitability to undertake physical activity and exercise. You will learn how to measure their current fitness status, within the scope of an exercise scientist, and provide feedback about their current fitness level relative to appropriate normative standards. You will further learn how to design and implement a training program, inclusive of strength and conditioning activities, suitable for an individual to meet their identified goals.
