Unit description

This unit examines the psychological, pedagogical, practical, and policy foundations of bilingual education in an increasingly globalised world. It presents an overview of the types of bilingual programs and the principles of effective bilingual education including theory, research, and effective strategies. This unit offers the opportunity to participate in an international/local trip and field experience in bilingual schools. Students participating in this field experience are expected to conduct additional research on a selected topic on bilingual education and write a research paper of their findings.

Special Consideration / Late Penalties

Applications for extensions must be made via Service Connect. After the 7th day, a mark of 0 (zero) will be awarded even if the assessment is

submitted. Submission time for all written assessments is set at 11:55pm. A 1-hour grace period is provided to students who experience a technical issue. This late penalty will apply to non-timed sensitive assessments (incl. essays, reports, posters, portfolios, journals, recordings etc). Late submission of time sensitive tasks (such as tests/exams, performance assessments/presentations, scheduled practical assessments/labs etc) will only be addressed by the unit convenor in a Special Consideration application. A Special Consideration outcome may result in a new question or topic.

Marking

All assessments are marked using a rubric.

Marking of all assessments is moderated by the Unit Convenor.
