Unit description This unit examines the psychological, pedagogical, practical, and policy foundations of bilingual education in an increasingly globalised world. It presents an overview of the types of bilingual programs and the principles of effective bilingual education including theory, research, and effective strategies. This unit offers the opportunity to participate in an international/local trip and field experience in bilingual schools. Students participating in this field experience are expected to conduct additional research on a selected topic on bilingual education and write a research paper of their findings.

A Special Consideration outcome may result in a new question or topic.

Marking of all assessments is moderated by the Unit Convenor.
