Unit description

This unit will equip you with an in-depth understanding of, and the ability to evaluate the applications of hearing aids, implantable devices, and assistive listening systems. The unit develops your understanding of the mechanisms by which hearing devices meet the needs of hearing-impaired people and the evidence for the effectiveness of a variety of technologies. In a wider sense this unit aims to equip you with the skills and information needed to evaluate existing and emerging hearing device technologies to provide evidence-based treatment.
