Unit description

This unit aims to equip you with an understanding of hearing aid systems and the principles of hearing aid measurement. It aims to familiarise you with the diverse range of hearing aids and wireless communication devices that are available. It will equip you with skills to determine appropriate hearing aid selection based on client need. You will practice impression taking, hearing aid measurement, hearing aid verification, electronic and acoustic adjustment of hearing aids. The unit will emphasize the importance of client centered practice and a holistic approach to rehabilitation.
