Unit description

This unit introduces The Arts and their role in the lives of children aged from birth to twelve years. It explores children's aesthetic and expressive development in drama, dance, music, and visual arts, and their use as symbol systems for making and communicating meaning. Students will gain practical and theoretical understanding of making, presenting, and appreciating in the Creative Arts. The unit considers the nature of creativity and provides opportunities for students to explore their own creativity and develop an understanding of children's creativity through The Arts.

Special Consideration / Late Penalties

Unless a Special Consideration request has been submitted and approved, a **5% penalty (of the total possible mark) will be applied each day to late submissions, up until the 7th calendar day (including weekends). After the 7th day, a mark of '0' (zero) will be awarded even if the assessment is submitted.** Submission time for all written assessments is set at 11.55pm. A 1-hour grace period is provided to students who experience a technical issue.

Important to note:

- Late submission of time sensitive tasks (such as tests/exams, performance assessments/presentations, scheduled practical assessments/labs) will be addressed by the unit convenor in a Special Consideration application.
- Students should not request an informal arrangement from their tutor, lecturer or Unit Convenor (or equivalent).
- Where an application for Special Consideration is approved and the outcome is an extension to the due date of a task, submissions that are received after the new due date will be subject to late penalties that are calculated from the new due date. Group creative performance

Students work in groups to present a short, combined dance/music/drama/Visual Arts piece. Students write an individual reflection on their work (500 words)
