Unit description

This unit examines “practice” in international relations and its interplay with “International Relations”, the scholarly study of the field. An overarching form of practice is “foreign policy”, within which “diplomacy” is a key element. The unit also considers “espionage”, “alliances”, “images”, “status”, “multilateralism”, “activism”, and some motives that influence international practice. It draws on and extends knowledge from across the Master of International Relations program and applies it to urgent and/or controversial themes. The unit enables students to (i) acquire and broaden specialist and general theoretical knowledge; (ii) develop and apply negotiation, communication, and practical problem-solving abilities; (iii) enhance research and writing skills.
