Unit description This unit covers theoretical models of psychopathology and evidence-based assessment and management of mental disorders in adults and children, including externalising, internalising, bipolar, psychotic, and personality disorders. Assessment techniques include interviewing children, adolescents, families, and acutely unwell clients (e.g., those experiencing psychosis), along with the use of self-report measures, behavioural observations, and child, parent, and teacher rating scales. The unit also addresses differential diagnosis, treatment planning, and intervention for comorbid conditions. Emphasis is placed on advanced therapy skills in evidence-based, case-formulated interventions, including outcome monitoring and adapting treatment based on evolving case formulations for complex and chronic presentations. It also covers consultation and collaboration with other professionals for clinical planning and referrals in complex cases.
