Unit description This unit covers the assessment, case formulation, and treatment interventions based upon evolving case formulations for stress and trauma-related disorders including adjustment disorder and complex trauma, somatization disorders, chronic pain, blood-injection-injury phobia, cardiovascular disease, cancer, and other health-related conditions. The focus will be on advanced and interdisciplinary approaches to the assessment, and the implementation of appropriate case-formulated interventions for specialised and complex mental health and illness populations. Models relevant to clinical health psychology will be discussed, including sociocultural factors in health.
