Unit description

This unit builds upon your knowledge and skills related to developmental and acquired brain impairment, how this can affect day to day functioning and emotional and psychological reactions to brain impairments. You will deepen your understanding of a neuropsychologist's role in intervention, recovery and rehabilitation following acquired brain impairment, models and theories of rehabilitation. You will develop and evaluate intervention programs for individuals across the lifespan.
