Unit description This unit provides an in depth examination of issues that can impact on cognitive test performance. Issues fundamental to differential diagnosis will be explored. You will be exposed to complex areas of clinical practice such as mild traumatic brain injury, autoimmune conditions and neurodegenerative conditions. Various secondary influences on neuropsychological functioning including sleep, fatigue, depressive disorders, trauma-related disorders, and anxiety disorders are detailed.
