Unit description

Interprofessional Case Management

Students will be presented with a complex case study. Working in small groups with other graduate health professional students, students will complete a multidisciplinary patient report based on a complex case. Alongside this and working individually, students will evaluate evidence and formulate detailed speech pathology management plans related to the case and reflect on their inter-professional experience.
