Unit description

In this unit, you will develop and enhance your assessment literacy and gain practical skills in language testing. Within the field of language testing within TESOL, you will gain insights into principles and techniques for designing and evaluating language tests and assessment tasks. The wider social context of language testing and uses of language tests will be considered. A unique feature of the unit is a language test and assessment project component, which enables you to establish links with educational and testing institutions and gain real-world experience in language testing and test development.
