Unit description

In this unit you will be introduced to the theory and practice of literacy studies from a social perspective. Drawing on social theories and research in literacy and linguistics, you will particularly focus on the sociolinguistics of language learning and multilingualism. In the unit, you will explore the nature of literacies, schooled and grassroots literacies, and literacies in their social, global, historical and technological contexts. Throughout the unit, you will reflect on literacies in your own field of experience and how these relate to fair and equitable access to social goods such as education, employment, welfare or community participation.

Artificial intelligence tools

Macquarie University recognises that artificial intelligence (AI), especially generative AI, is rapidly reshaping education and the modern workplace. AI Open assessments allow you to fully incorporate AI, reflecting authentic tasks where AI would normally be used in professional settings.

Observed with AI Optional assessments involve tasks where you either demonstrate essential knowledge without technology or show how you apply AI under supervision.

Across both categories, the goal is to ensure you build foundational knowledge, exercise sound judgment, and engage with AI in ways that uphold ethical, cultural, and university values.
