Unit description

In this unit, you will be provided with a general introduction to the nature and study of psychopathology, as well as diagnosis. Each of the main forms of psychopathology is discussed. Research and theory are reviewed, while assessment and science-based interventions are noted. An intermediate level of research methodology and statistical knowledge is a pre-requisite for this unit, as this knowledge is required to understand the scientific basis of psychopathology and its theories.
