BHIX 1004 - History and Heritage

Unit description

"History lives all around us—in heritage-listed buildings, our local museums, our streets, memes and community memorials. But why are some places protected while others are destroyed? How do communities fight to preserve their stories, and what happens when people remember the past differently? You'll discover how local communities research their own histories, how museums choose stories to tell, and how digital technologies are revolutionising our encounters with the past. Whether analysing a campaign to save a historic building or a major exhibition on frontier violence, you'll understand how public history shapes who we are. This unit introduces how history works in the real world, shaping community and national identity, politics, and cultural memory. You'll journey through global approaches to heritage, from colonial collecting and Indigenous requests for repatriation, learning practical skills that heritage and history professionals use daily: assessing cultural significance, developing conservation plans, managing collections, and creating interpretations that bring the past to life. By unit's end, you'll see history and heritage everywhere, and understand the forces determining which stories survive in the public realm.

General Assessment Information

Late Assessment Submission Penalty
