Unit description

Who holds power in the world, and how is it exercised? This unit introduces students to how power operates in the global system through governance, contestation, and the structures of the world economy. It focuses on three core frames (state power, global governance, and political economy) that provide a foundation for interpreting international affairs. Students will examine theories and concepts of international politics, and key actors and structures including states, international organisations, trade and security frameworks, corporations, and transnational movements. Case studies and scenario-based activities illustrate how systems emerge, evolve, and interact across local, regional, and global contexts. The unit explores how agendas are formed and challenged, how global power is distributed and disrupted, and how economic structures shape political outcomes. Institutions such as the United Nations, regional organisations, and global trade frameworks are studied alongside contemporary dynamics including rivalries between established (and emerging) global powers, the role of middle powers, and multilateral cooperation in a fragmented order. By the end of the unit, students will have a structured framework for understanding the systems that underpin global affairs and will be prepared to apply this knowledge in subsequent units of the Bachelor of International Studies.

Case Studies: Actor Mapping

Assessment Type ¹: Problem-based task

Students engage in a small-group mapping activity to analyse a global issue governed by overlapping authorities, examining how power operates across states, institutions, and economic structures.

On successful completion you will be able to:

- Identify the structures, actors, and institutions underpinning global governance and political systems.
- Develop an understanding of the distribution and contestation of power across societies, institutions, and international systems.
- Apply analytical tools to identify the interconnections between actors, interests, and norms in real-world complex systems.

Simulation Activity

Assessment Type ¹: Presentation task

Indicative Time on Task ²: 35 hours

Due: **18/10/2026**

Weighting: **40%**

Groupwork/Individual: Individual

Short extension ³: Yes

AI Approach: Open

Students participate in a structured negotiation activity based on a shared case and shock scenario, then deliver an individual recorded video presentation analysing who is affected by the shock, how power shifts, and which analytical frames best explain what happened.

Reflective Writing

Assessment Type ¹: Reflection task

Indicative Time on Task ²: 25 hours

Due: **06/11/2026**

Weighting: **35%**

Groupwork/Individual: Individual

Short extension ³: Yes

AI Approach: Open

Students complete three short reflections across the semester, which are then combined into a single reflective writing task that tracks how their understanding of global power evolves. The reflection draws on readings, class discussions, and learning activities.

- Develop an understanding of the distribution and contestation of power across societies, institutions, and international systems.
- Apply analytical tools to identify the interconnections between actors, interests, and norms in real-world complex systems.
