Unit description

This unit examines fundamentals of determinants of health in two modules. In the first module, you will learn about social, behavioural and structural determinants of health. In the second module, you will be introduced to biological and environmental factors that impact health status of individuals and populations. You will explore the linkages between determinants of health, and how this impact individuals and communities. This will encapsulate concepts related to what supports good human health, and what contributes to human illness. You will explore contemporary and emerging challenges to public health and develop conceptual and practical knowledge essential for a career in public health.
