General Assessment Information

Late Submission Penalties

The purpose of this assessment is to develop your ability to apply ethics and sustainability theories to real organisational contexts, critically evaluate corporate practices, and communicate evidence-based recommendations.

You will work in a group to research and assess the ethics and sustainability performance of a selected organisation. Your team will prepare a written report that analyses the organisation's policies, practices, and leadership, and provides justified recommendations for improvement. Each student will also deliver an individual presentation summarising their section of the report and reflecting on the organisation's performance.

Deliverable(s): Group written report [max 2500 words] and individual presentation (max 5min)

You will write a self-reflective, conceptually informed essay that explores what has most challenged your values or assumptions during the unit, and how you can apply ethical reasoning in your future practice.
