Unit description

This unit further develops concepts introduced in CHIR6101 Chiropractic Clinical Practice 1. You will be introduced to the biopsychosocial factors associated with the pain experience, prognosis, and the development of chronic pain and disability. You will further develop your patient communication and clinical assessment skills to identify risk and prognostic factors and consider how these impact patient education, management, and prognosis. You will continue to develop your psychomotor skills and learn to perform a core group of manual therapy and rehabilitation techniques, including joint manipulation, soft tissue techniques, and muscle length, strength, and endurance exercises.
