## Dissertation submission

Due: **23/10/17**

Weighting: **100%**

Submission of a 5000-8000 word dissertation. This may take the form of a traditional empirical research project (most commonly), a study based on experimental single case design, a systematic review or meta-analysis, or a program evaluation study.

It should be formatted according to the guidelines in the APA Style Manual (6th edition); in this context, the requirement in past years to format the manuscript for a specific journal is no longer relevant.

Submit three bound copies to the Postgraduate Coursework Officer (one copy for each of the examiners and one for your supervisor). Plastic spiral binding is acceptable. In addition, you need to send a PDF of the thesis to [psy.pgofficer@mq.edu.au](mailto:psy.pgofficer@mq.edu.au), as some examiners request a PDF instead of hard copy.

Extensions must be requested via [ask.mq.edu.au](http://ask.mq.edu.au) with a letter of support from the supervisor(s) and evidence justifying the extension as appropriate. Late submissions will be penalised by one mark for each day beyond the submission date.
