#### Assignment 1

Due: Week 6 Weighting: 20%

For this assignment, you are required to submit a critical review of an academic article, in a multimedia video format. You will be provided with a selection of articles on interpreting and translation theory, and asked to select one article. You are required to prepare and present **orally** a critical review of this article, in a **multimedia** format of your choice (a video, Prezi presentation, podcast, narrated slideshow, etc.), which should be recorded for submission. The multimedia video presentation should be 5-7 minutes in duration. The assignment will be assessed using a rubric provided on iLearn.
