Unit description The unit aims to combine archaeology with history in the study of a number of key cities of the Roman Near East. The Silk Road and the Frankincense Road brought great prosperity to a number of cities of the Roman East, especially Petra, Palmyra and Dura Europos. Much of the history of these cities is written from a combination of archaeological reports and literary sources. Students will be given the opportunity to learn how to evaluate archaeological evidence against extant literary sources and also to study the architectural history of the Roman Near East.

Students will be assigned to a group of 3 or 4 students which will prepare and present a 30 minute seminar in weeks 4, 9 or 12. The seminar will be followed by 15 minutes of discussion with the rest of the group to be co-ordinated by the presenters. Groups and class presentation times will be assigned in the first seminar. A powerpoint presentation should accompany each presentation. You may use any of the material used by me in the presentations in the weeks before and you are also expected to use material which is self-located.

## Major Essay
