## Literature review

Word count: 1200 words

Write a review of selected literature from Module 1 (Critical perspectives on globalisation and sustainable development) that considers how globalisation and sustainable development are presented in the readings and outlines key synergies and tensions between discourses of globalisation and sustainable development. ## Critical reading

Word count: 1000 words

Select one reading from Module 2 (Rethinking globalisation and sustainable development) and one current media report (a newspaper clipping or online news feature) that is related to this reading. Write a critical analysis of your selected Module 2 reading, relating it to the media report you have gathered. See further details and marking rubric in iLearn.

- Case Study 2: Ecovillages
- Case Study 3: NGOs
